Consumption & Fixed Charges

Billing for water and wastewater services is generally based on three factors:

- 1) Fixed quarterly service charges based on the water meter size;
- 2) Flow or volume charges reflecting the consumption recorded by the meter; and
- 3) Public fire protection based on improvement value of the property.

Public Fire Protection

The rate structure for Public Fire Protection charges is based on the assessed value of the improvements on a parcel of land and not on the property's total assessed valuation. This charge is for the ability to deliver a large quantity of water quickly to the location of a fire. It includes the cost of water pumping, reservoirs, mains and fire hydrants. The value of the improvements on your property can be determined by reviewing the most recent property tax bill.
